## LIFETIME NON-PRORATED TRANSFERABLE WARRANTY

US Aluminum, Inc. warrants to you, the original purchaser of Gutter Shelter, that under normal use and proper maintenance, this product will be free from defects in material and workmanship for as long as you reside in the home in which Gutter Shelter was installed. The details of the warranty are as follows:

### PANEL AND ACCESSORIES LIFETIME NON-PRORATED

Gutter Shelter's panel and accessories will be free from manufacturing defects for as long as you live in your home. This warranty is transferable.

### DURA LIFE PAINT FINISH LIFETIME NON-PRORATED

Gutter Shelter's paint finish will not blister, peel, flake, chip, or crack for as long as you live in your home. This warranty is transferable.

### LIMITATIONS

US Aluminum, Inc. warrants only the manufacturing defects on the panel, accessories and paint finish. US Aluminum, Inc. is not responsible for circumstances beyond its control, such as (but not limited to), improper installation, accident, hail, fire, flood, explosion, wind blown objects, salt spray, harmful chemicals, abuse, vandalism, or improper maintenance. US Aluminum, Inc. is not liable for any incidental or consequential damages resulting from any defect or expenses except as expressly provided herein. This warranty gives you specific legal rights; you may have other legal rights which vary from state to state.

This warranty covers material only. US Aluminum, Inc. will assume no other expense such as labor costs for removal or re-installation. US Aluminum, Inc. will pay all shipping costs related to failure of the product.

### CLAIM PROCEDURE

You must promptly notify US Aluminum, Inc., in writing, of any manufacturing defect following its discovery at:

Include with each claim a copy of the original warranty and a copy of the contract with the installing contractor, and three photos of the failing product. If US Aluminum, Inc. cannot determine whether or not the paint finish has failed by examining the photos, it may require a section of the product to be sent to the above address. US Aluminum, Inc. will pay all shipping costs related to the failure of the product.

### CARE AND MAINTENANCE

Gutter Shelter is designed to be virtually maintenance free. However, in some areas, dirt or some debris may build up on the front edge of the panel. Dirt or debris buildup may cause dripping in those areas that have the buildup. An annual spray cleaning of the top/front edge of the installed system with a hose or pressure hose will help maintain the performance. In areas where pine resins or excessive tree sap is prevalent, a periodic cleaning with a mild detergent may be necessary.

### WARRANTY REGISTRATION
